The Brentwood Local Plan Pre-Submission Document and the Addendum of Focussed Changes to the Pre-Submission Local Plan, which together form the Plan, was submitted to the now Secretary of State for Levelling Up, Housing and Communities, for examination on 14 February 2020. The Secretary of State appointed Inspectors Yvonne Wright BSc (Hons) Dip TP DMS MSc MRTPI and Mike Worden BA (Hons) Dip TP MRTPI, to conduct an independent Examination of the Local Plan.

Notice is hereby given in accordance with Regulation 25 of the Town and Country Planning (Local Planning) (England) Regulations 2012, that on 23 February 2022, Brentwood Borough Council received the Inspectors' Final Report on the Examination of the Brentwood Local Plan 2016-2033. The Report sets out the Inspectors' recommendations and their reasons for them.

The Inspectors' Report concludes that subject to a number of main modifications, set out in the Appendix to their report, the Brentwood Local Plan 2016-2033 is sound, legally compliant and capable of adoption.
